HOW TO ENTER

Related Bodies Corporate means the definition given to the term in the *Corporations Act 2001* (Cth).

CONDITIONS OF REDEMPTION

- 1) Each customer will only be entitled to redeem one (1) Gift per day, per Eligible Spend during the Promotional Period **only while stocks last.**
- 2) To redeem a Gift, each customer will need to:
 - a) present valid receipt/s of their transaction(s) from one or more Participating Retailers to evidence of the Eligible Spend; and
 - b) complete all fields required by the Promotor on the entry form.

For the avoidance of doubt, lay-by receipts, bill payments such as the payment of credit card bills, bank transactions, bank fees and charges and service bills (such as gas, electricity, rates and phone bills) are not valid receipts for the purpose of this Promotion.

- 3) The Promoter reserves the right to disqualify any entry by a customer that:
 - a) contains material considered by the Promoter to be inappropriate or offensive; or
 - b) was submitted in a manner considered by the Promoter to be inappropriate, which may include, but is not limited to, actions relating to forged, mutilated copied or tampered receipts, computer hacking, breach of copyright or other intellectual property rights and actions that breach any relevant laws.
- 4) Customers who present an eligible receipt and registration after 2pm Friday 24 December 2021 or after 'gift' stocks are depleted, will not be eligible to redeem a Gift.
- 5) The following person(s) are not eligible to enter the Promotion:
 - a) Employees of:
 - (i) the Promoter;
 - (ii) the Promoter's related bodies corporate (as defined in the Corporations Act 2001 (Cth)); and
 - (iii) agents, consultants and contractors engaged by the Promoter.
 - b) members of the Immediate Families (as defined in the *Family Law Act 1975* (Cth) of the employees referred to in paragraph 5(a).
 - c) If the customer is under the age of 18 years, the Gift will be awarded to the customers nominated parent or guardian.
- 6) The Promoter reserves the right, in its absolute discretion to verify the validity of receipts and to disqualify any customer who tampers with the redemption process or who submits a receipt that is not in accordance with the Terms and Conditions.
- 7) To the extent permitted by law, the Promoter reserves the right to amend, modify or change the Terms and Conditions of the Promotion, in its absolute and sole discretion, including the right to cancel the Promotion in its entirety and not award the Gift where circumstances, beyond the Promoter's reasonable control, prevent the Promoter from awarding the Gift. If the Promoter cancels the Promotion, the Promoter will:
 - a) advertise that the Promotion has been cancelled by placing a notice in the Participating Centre;
 - b) promptly destroy all entries received; and
 - c) not use the information that any customer has provided on the entry form.
- 8) Gifts are not redeemable for cash, not transferable and must be taken as offered. All Gifts must be collected from the "Parcel Porter Lobby" opposite Flight Centre at the Participating Centre by 2pm Saturday 24 December 2021 or until stocks last.
